Candidates applying for the Admission to MBA Course (Session: 2017-2019) are hereby informed regarding eligibility, cost of making application & Prospectus for General and Quota Seats for Admission to MBA Course of the Department of Applied Economics and Commerce, Patna University, Patna:

Note Carefully:

01. Applications are invited from eligible and desirous candidates with valid score of **MAT/CAT/XAT/ATMA/JMET** for admission to 2-year (Four Semesters) full-time MBA Programme for the Session: 2017-2019.
02. Any student of the Faculty of Arts, Humanities, Science, Commerce, Business Administration, Labour, Engineering of Patna University or of any other Universities recognised by the Academic Council of Patna University as equivalent there to, who have passed degree level examination securing 45% of the aggregate marks, is eligible to apply for admission to MBA Course. The appearing candidates may also apply, provided that they will have to submit their original marks sheet showing 45% of aggregate marks at the time of their admission.



03. Candidates shall have to submit their application online. For detailed information, candidates may visit the website of Patna University. Detailed information about admission can also be had by visiting the website of the Department or by making contact directly with the Office of the Department of Applied Economics & Commerce, Patna University, Patna between 08 am to 02 pm.
04. Candidates desirous of taking admission on 'Paid Seat Quota' and 'Sponsored Seat Quota' respectively are required to give option for the same at the time of submission of their application and for this they will have to pay extra Rs. 50/- (Rupees Fifty) only each for the respective quota/quotas.
05. For the sponsored seats the candidates should be sponsored by a reputed company.
06. Selection for the 'Paid Seat Quota' and 'Sponsored Seat Quota' shall be made only on the basis of merit.
07. The merit list shall be prepared on the basis of aggregate of Score obtained in the **MAT/CAT/XAT/ATMA/JMET** and the marks secured in Group Discussion & Personal Interview (GDPI), each of 200 marks, by the eligible candidates. The date and time of GDPI shall be notified later on.
